Bruce Ohr of the United States Department of Justice communicated with Christopher Steele regularly (violating the separation of Departments requirement)

Peter Strzok of the FBI, 8. Bruce Ohr of the DOJ, 9. Fusion GPS researcher Nellie Ohr the wife of Bruce Ohr, 10. Christopher Steele, 11. Oleg Deripaska, 12. Serge Millian, and a number of additional Russian associates, we are not yet going to name, all had communications and most took actions to further the production of the Steele Dossier (which turned out NOT TO MEET THE FBI CRITERIA FOR AN EVIDENTIARY RECORD), which constitutes not only collusion but conspiracy.

Further one of the four reasons given for launching a Russia collusion investigation, the firing of James Comey, was actually insisted on by Rod Rosenstein (the FBI to date cannot get their story straight as to what the first threat assessment was to initiate an investigation into the Trump Campaign; Carter Page, George Papadopoulos, the statements about General Flynn or the firing of James Comey, and for that matter there is nothing in any department file that shows any threat assessment from the bottom up, that went through the normal process with oversight but instead just the opposite as the communications show top down instructions to launch the sham Russia collusion investigation).
