SUMMARY

WE NOW KNOW THE FOLLOWING:

- The former Obama Administration and Hillary Clinton Campaign had DIRECTED parties from Russia and the UK, including former members of GCHQ and MI6 to facilitate the Christopher Steele Dossier. These parties particularly engaged Marc Elias of the 2016 Presidential Counsel of Hillary Clinton, Perkins Coix (merging the interests and financial resources of the U.S. Government and the most important private campaign in the land), Bruce Ohr, Nellie Ohr and the minimum of an additional 21 parties who were involved in the scheme.
- Marc Elias of Perkins Coix is best friends with Robert Kelner, attorney for Lt. General Flynn.
- Robert Caron informed Lt. General Michael Flynn of a series of strange phone calls and texts placed to Robert Caron from former CIA Director Robert James Woolsey, his wife Nancye Miller, Mike an operative for Mr. Woolsey, and an anonymous source. These parties were eluding to a very important project pertaining to China. Eventually an anonymous source, in between the phone calls and texts, requested that Robert Caron locate sources from the Intelligence Community or anywhere to gather information about how Lt. General Flynn had planned to remove Fetullah Gulen from the United States and transport to Turkey that had been broadcast several months before. When Robert Caron refused to have anything to do with the outlandish allegation, the party made clear that Jim would pay one million dollars for evidence that would hold up in court and conveyed more or less the information could be manufactured by saying "I am sure you can find something for that kind of money." Then asked questions about how anyone could carry out such an operation and offered two scenarios. It was obvious they were fabricating a narrative. I am attaching verified time stamped texts between Jim and I between October 26, 2017 and October 29, 2017 (the same day as the meeting @ 1539 29th Street, DC 20007 whereby informant claims communications with Jim delegate regarding status of RM making something stick against your father, and slanderous attacks they had been planning against President Trump, the Mercers and Wynn, during the same context of Keltner Elias matter and the angle of Jim & Nancye).

During that period 10 26 2017 to 10 29 2017, Jim persistently tried to communicate with me directly and via his wife Nancye, his associate Mike and an anonymous party through texts and phone calls. I thought the motive for Jim persistently trying to communicate with me had to do with my thoughts on India and China political and economic variables, and Turkey assessments. However, the one conversation I had with the anonymous party started out about the deception of Turkey and then digressed to blatantly trying to conduct a smear campaign against your father pertaining to abducting Gulen.

I was clear I had no information nor would I participate in any effort against a present or former Administration official. During the conversation the anonymous party clearly was not trying to further develop any real lead that was being investigated but was trying to fabricate some narrative due to the speech pattern and inserting the word "or" regarding scenarios he was presenting. Also there were supposedly a minimum of two sub group meetings during Cockroaches dinners around same period where planning against your dad and against Trump Administration took place.

- Robert Caron informed Michael G. Flynn and Lt. General Michael Flynn of the exchanges.
- Robert Caron emailed Robert Kelner back and forth and told Robert Kelner about evidence of parties trying to frame Lt. General Flynn, and the communications between Robert James Woolsey, Nancye Miller, Mike and an anonymous party, and offered to testify. This prompted Robert Kelner to thank Robert Caron and act like he was going to take immediate action, however, Robert Kelner would not return calls or communicate back.




- An emergency meeting was called on January 5, 2017, between President Obama, Vice President Biden, Deputy Attorney General Sally Yates, FBI Director James Comey and Ambassador Susan Rice to address the Russian Collusion narrative progress. - James Comey committed perjury when testifying at the Senate Intelligence Committee, about attending the meeting with President Barack Obama, Vice President Joseph Biden, Deputy Attorney General Sally Yates, Ambassador Susan Rice and himself on January 5, 2017. According to reports **they discussed how the Russian collusion narrative was proceeding and talked about the assistance by the UK and how Flynn was the first party that had to be removed. Sally Yates then reported about UK operations. There was discussions about the revisions to Executive Order 12333 that James Clapper modified on December 15, 2016. Then Loretta Lynch completed it on January 3, 2017, just two days before the January 5, 2017 emergency meeting. They had already directed the NSA to share raw data with the FBI prior to being legally able to share direct information on United States Citizens without filtering.**
- One of the major issues was how they were going to explain the surveillance and what they were doing (because they did not expect Candidate Donald Trump to be in the White House).

A memo had been written by Ambassador Susan Rice on inauguration day January 20, 2017, declaring that President Barack Obama had insisted they do everything by the book (implying they do not always do things by the book).

"From a national security perspective, however, President Obama said he wants to be sure that, as we engage with the incoming team, we are mindful to ascertain if there is any reason that we cannot share information fully as it relates to Russia," Rice wrote. "The President asked Comey to inform him if anything changes in the next few weeks that should affect how we share classified information with the incoming team. Comey said he would."

HOWEVER, THE OBAMA ADMINISTRATION DID NOT SUBMIT THE ENTIRE INFORMATION TO THE INCOMING ADMINISTRATION.

The outgoing Obama Administration, as we are now aware, did not fully cooperate. Not only did the Obama Administration not cooperate fully with the transition, they put in motion **an assault against President Donald J. - Their first attempt at real capitalism was fraught with corruption from the Russian mafia and some oligarchs, and accordingly that philosophy of cheating people in transactions became a main protocol in their everyday commerce. A movement occurred and many converted away from communism and atheism to Christianity. President Putin led the way.
- The United States should be doing everything we can to support Russia being financially stable and working together. We should exchange select information about traitors who are working within our governments. Especially those who are actually communist and hostile to our U.S. Constitution. We should also cooperate in the movement of key subject matters with Russia, but not hand over any U.S. Citizens for interrogation.

- There continues to be illicit commerce by two main oligarchs who assisted electing President Putin, and who also thought Hillary was more likely to win and so they supported her too, but all in all, these Oligarchs, while following the end justifies the means philosophy in many situations, just like the Kremlin to a degree but not as much as before, are pursuing money more than having a political ideology.
- IF WE DO NOT START FOSTERING THIS RELATIONSHIP THEN WE PUSH RUSSIA TO WORKING MORE WITH CHINA AND AGAINST OUR INTERESTS.
- Of course we have to pursue building a better relationship with China, however, China is set in their ways more so than Russia. China continues to deny freedom and human rights to their citizens.
- This does not mean we do not have to always keep watch over all communications and transactions with Russia, just like any other country. For the American People to fully grasp this Report, these factors about why General Flynn had to continue to nurture relations with Russia are very important, and also why the Obama Administration sought to interfere with that process.

THEREFORE, ENCOURAGING COMMUNICATIONS WITH RUSSIA WAS PARAMOUNT AND GENERAL FLYNN DID NOTHING WRONG BY COMMUNICATING.

This is the backstory, so everyone understands the importance of why parties were communicating with Russia and ingratiating ourselves to many of our global neighbors during that period.

The Obama Administration and Clinton et al worked IN CONCERT (which is absolutely illegal) to deride the Trump Administration starting with General Flynn:

They attacked his son in order to leverage him!

Expelled Russian dignitaries prompting a reaction from Sergey Kislyak who called General Flynn immediately.

During all of this commotion the FBI aggressively attacked General Flynn, forcing a confrontation between General Flynn and Vice President Michael Pence. General Flynn, as an automatic reaction to do his duty, could not immediately tell Vice President Pence details about communications because he could have been in violation of the MOSAIC ACT and consequently the ESPIONAGE ACT. Any good attorney should have advised him of that accordingly.

There was poor representation of General Michael Flynn by Robert Kelner (**BEST FRIEND OF MARC ELIAS WHO REPRESENTED HILLARY CLINTON IN THE PRODUCTION OF THE FAKE DOSSIER**), including the refusal of key exculpatory evidence and bringing up the most basic of defenses that was absolutely TRUTHFUL. In addition, there was overwhelming evidence of the conspiracy by high ranking members of the Obama Administration and those controlled by Hillary Clinton in conjunction with UK bad actors and Russian (not necessarily directed by President Putin) bad actors.
